*You do not have to list income from alimony, child support, or separate maintenance unless you want us to consider it for purposes of opening this account. Additional information and signatures may be required. By signing above, you also verify that everything stated in this application is correct to the best of your knowledge. You understand that it may be a federal crime punishable by fine or imprisonment, or both, to knowingly make any false statement concerning any of the above facts as applicable under the provisions of the United States Criminal Code. By signing above, you authorize Numerica to verify your credit and employment history, obtain a credit report, obtain further credit information for periodic review of your account(s), and make its experience with your account(s) available to credit bureaus or provide information about your account(s) to any person or entity when required by law.
